Reign Of terror in Puri

An Oriya leader who recently visited Puri writes as follows:-

My visit to Puri enabled me to gather first-hand information about the situation there and it seemed to me that there is practically a reign of terror in the holy city of Jagannath. The Raja who is the pope of India is being treated as a felon. A man is sitting at the door of his palace and taking down names of persons visiting him.

Persons suspected of being in sympathy with the Raja are being subjected to espionage.

The Raja is being officially threatened with criminal prosecution and civil proceedings.

The Government pleader was the carrier of a message to the Raja that his political pension would be stopped and that the Temple would be taken out of his hands if he did not accept the Government nominee. Subsequently these threats were confirmed in an official letter.

In a letter to the Raja, a High official said to the effect "Answer my questions orally as

soon as they are put to you by the bearer of this letter otherwise I will presume that you are a liar". This is an interesting procedure which ought to be patented.

An attempt was made to drag the Raja to the Court and thereby harass him though he was neither a complainant nor an accused.

The present Manager who wished to go on leave two months ago on urgent medical grounds is still there and is flourishing well.

The Raja asked for the services of a competent Oriya. That was refused and the authorities are on the war-path against him. It can be imagined who has created the situation.

Baffled in their attempt to coerce the Raja to execute an agreement in favour of a man he did not nominate or he does not wish to have, the authorities are trying to set against him one of his two adopted sons with whom he had prolonged litigation and thereby practically sowing the seed of discord and litigation. It has been ignored that the course proposed to be adopted will not meet with the approval of the public for other reasons which are matters of common knowledge.

An attempt is also being made to set Beharis against Oriyas and set up Behari candidates. A nobleman of Bihar has been approached to lead an agitation to influence Government.

Certain officials are having an awful experience. One whose name was suggested by the Raja for the post of Manager has been transferred from one end of the Province to the other and he is in danger of losing his promotion. His accuser has been put in power. One has been transferred to heaven and it is said that he has thereby avoided his transfer to Bihar. Another a conqueror of many battles has incurred the wrath of Achilles. We are not sorry for him for he merged himself completely in the bureaucracy and now he is being paid in his own coins. Let the world know how long the love of the Bureaucracy lasts. The unobliging District Sub-Registrar who was taken to the Raja's office to register the agreement in favour of the Government nominee and who pointed out the irregular procedure adopted, is under a cloud.

A whitewashing machine has been procured and it is being greased.

If Government did ever that corruption had vanished from the realm by the touch of some one's magic wand, except from the Nahar of the Raja of Puri where it would be stopped if the Raja was disgraced of his power, they will be ashamed, when they come to know what has happened in connection with the appointment.

In short, zid, anger, overzealousness, intrigue, ignorance and misrepresentation of facts have all combined to create an unpleasant situation for Government and the Oriya public and it is difficult to imagine how it will lead. Justice is impossible where zid and anger reign supreme.

It is necessary that the whole question should be taken up by entire Utkal in right earnest.
