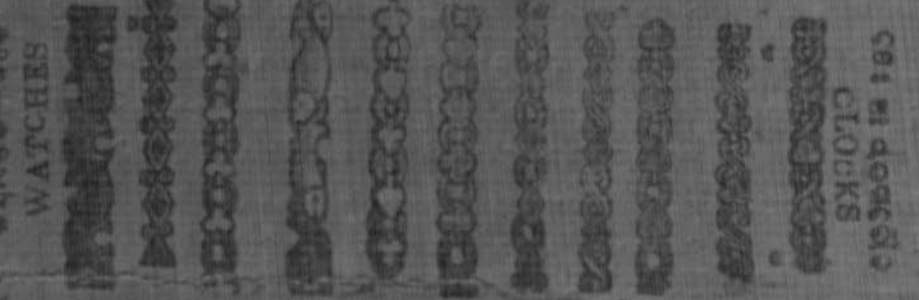

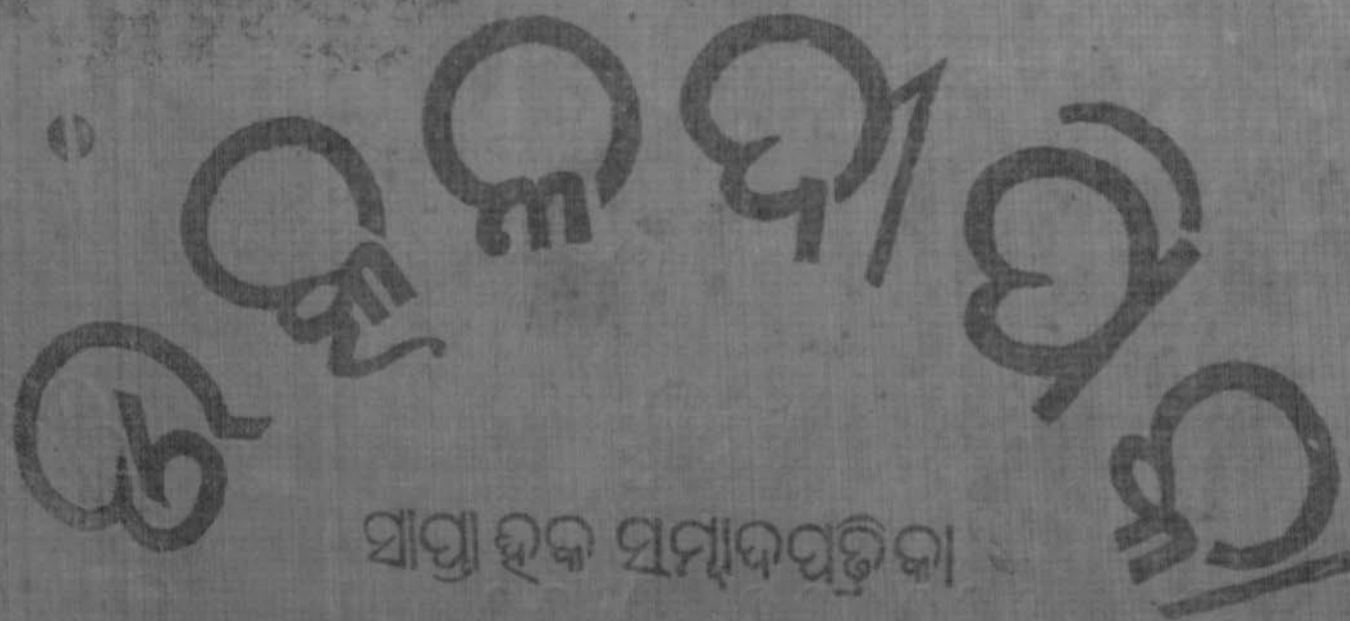

I therefore ask you to bear this central fact in mind when you talk of the grip of the political helm. The fact is this. Political life, in its hitherto accepted sense, has so long consisted merely of the articulate minority who attended meetings and supplied copy to the newspaper.

Now, my friend, the man or the party leader who will gather together in his party a number of followers who will be prepared to spend money on canvassing or other necessary (and legally permissible) election expenses, who will set up local organizations for influencing the voters living in the back slums in towns and voters living in the country side, that man will win the day.

I am convinced that in Bengal neither Surendranath nor C. R. Das holds the winning cards in his hand. Neither of them is so far doing anything to organize matters to capture the votes of the inarticulate masses. Until they do so, and until their followers come to the fray with a well-filled purse and loosen their purse strings, their chances at the polls will remain thoroughly uncertain.
